Multiplayer sessions operate over Unity Transport, which uses networked communication solely for gameplay synchronization and does not involve the transmission or storage of personally identifiable information. All AI processing, including conversational and gameplay-related inference, is performed locally on-device via an offline language model running through llama.cpp. No voice data or audio files are transmitted to external servers for processing. As such, Jamboxx Infinite is fully compliant with the General Data Protection Regulation (GDPR).

Jamboxx Infinite operates under a closed-source license model. Users are granted a license to use the software according to the terms outlined in the End-User License Agreement (EULA). The source code is not publicly available and remains accessible only to authorized development personnel.

Jamboxx Infinite does not integrate with third-party analytics, ad networks, or external AI APIs. All services are hosted locally or on secured internal infrastructure.
